Order Of Provisional Fee

1. A Proposal has been filed by applicant school to determine fees for the year 2018 - 2019.
2. Application School is Affiliated with CBSE Board.
3. School is English Medium School.
4. School is Situated At. Charwada Gunjan Road , Ta. Pardi , Valsad.
5. This Proposal is for Nur. to 10.
6. The committee has received this proposal for f. Y. 2018 - 2019 to determine the fees of the school. The committee has thoroughly gone through the Papers , Documents, Accounts and Other information submitted by the school.

After considering all aspects such as strength of students , strength of teachers, non- teaching staff , facilities provided by the school, activities carried out by the school, Fees structures , Income & Expenditure etc. , the provisional fees of the school for the F. Y. 2018 - 2019 is determined at the Rate 7% higher of the fees determined for F. Y. 2017 - 2018 and the same shall remain in force till the committee finally determines the fees or it is altered or amend or modified by the Fees Revision Committee or by Hon' ble Supreme Court, in appropriate proceedings.

Conditions:-

1. The school shall not collect fee amounting to more than one quarter fee at one time from any student.
2. School shall not collect more fees except above under any pretext .
3. The fee determined by this committee shall be displayed by the applicant on its notice board and official website in Gujarati and English language.
4. The admission fees to be charged by the school shall not be more than one month of the tuition fee.
5. The Term fees to be charged by the school shall not be more than one month of the tuition fees, The school shall not charge term fees for more than two terms.
6. Excess fee if any collected by the school shall be refunded through a/c payer cheque or it may be adjusted in next year.
7. This Provisional Fees determined by the committee shall be subject to the final determination that may be made by the committee, after considering the objections received by the committee, if any and as may be altered, amended or modified either by the fee revision committee or by the Hon'ble Supreme Court of India in appropriate proceedings.

8. If the school is aggrieved by provisional fees determined by the committee , it shall raise an objection before the committee within 7 days from the date of receipt of this order.
